







<p>Buttons and Functions This product permits one person to speak to countless people at the same time in a long distance without interference. (Only the transmitter sends the signal to the receiver).</p>  <p>1</p>	<p>LCD Display</p>  <p>Operation Instruction Step 1: Turn on transmitter/receiver Long press Power On Button [] for 3 seconds to turn on the transmitter/receiver; the signal, battery level, volume and channel icons will be shown on the LCD display. (The signal icon appears only when the receiver and transmitter in the same channel).</p>  <p>2</p>	<p>Step 2: Insert microphone/earpiece Insert the microphone to the MIC jack on the transmitter, and insert the earpiece to the Earpiece jack on the receiver. Note: DO NOT insert Microphone/Earphone wrongly into charging port to avoid damage the charging on inside.</p>  <p>3</p>	<p>Step 4: Set the Channel By Manual Press the Power Button [] when the CH icon appears on the display, press the Up Button [] or Down Button [] to select the channel that you need to use. Note: It is the same way for the transmitter and receiver to set the channel.</p>  <p>4</p>	<p>Channel Synchronization This is the faster way to set the channels for transmitter and receiver. You could synchronize the channel by operating the transmitter instead of changing the channel of the receivers one by one. A. Press the Power Button [] on the transmitter, the CH icon will appear on the display. B. Press Up [] or Down [] button to select the channel that you want to use. C. Then long press the Up Button [] and observe the screen of the receiver, release the Up Button [] after the channel on the receiver is changed. Then channel synced successfully. Note: When you set the channel synchronization, please make sure the receiver is turned on and within 5m from the transmitter.</p>  <p>5</p>	<p>Key Lock Function Long Press the Down Button [] for 3 seconds to lock/unlock keys</p> <p>One-key Mute Transmitter and receiver channel synchronization: If you need to quickly adjust all receiver speakers to mute, just operate the transmitter. 1. Press the [] button on the transmitter, the "CH" icon appears on the screen; 2. Press the [] button again, the "VOL." icon appears on the screen. 3. Press and hold the [] button again and observe the screen of the transmitter. Release the button after "M" appears, and the one-key mute is successful. 4. Long press the [] button again to unmute.</p> <p>One-key shutdown Transmitter and receiver channel synchronization: If you need to turn off all receiver power, operate the transmitter. 1. Press and hold the [] button again and observe the screen of the transmitter. After "MIC" flashes, release the button and the one-button shutdown is successful.</p> <p>Note: 1. Kindly handle it carefully and avoid falling it down. 3. Already controlled receiver's channel won't be changed by its neighbouring transmitters from other groups at any time at the same place by any operations. 4.
