 Turn on the transmitter, a blue LED will start blinking and then turn on the receiver. The pairing process take about 2 seconds to complete. If the pairing is complete, the blue LED on both receiver and transmitter will always stay on. Next plug in the receiver into the amplifier or any audio devices.

2. When using it, if the LED light start blinking rapidly it means that the devices is running out of battery and remember to charge it. In charging mode, the LED will stay on red color. If charging is complete the red LED light will turn off. Note: When the device is turn on, It will auto detect and connect automatically.


